What is the interest rate?			
<ul style="list-style-type: none"> <li>• Interest rate 4% AER for new subscriptions for the year 2026-2027</li> <li>• Interest rate 2.5% AER for previous years subscriptions that you wish to transfer in.</li> <li>• This rate is fixed for the full term of the account.</li> <li>• Interest is calculated daily on your balance.</li> <li>• Interest is paid annually and will be paid into your Fixed Cash ISA within 7 days of maturity.</li> </ul>			
Can 1 <sup>st</sup> Class Credit Union change the interest rate?			
No. The interest rate is fixed and will not change during the term.

How do I open and manage my account?			
<ul style="list-style-type: none"> <li>• Eligibility: <ul style="list-style-type: none"> <li>○ Aged 18 or over.</li> <li>○ UK resident for tax purposes.</li> <li>○ Must be a member of 1<sup>st</sup> Class Credit Union.</li> </ul> </li> <li>• Minimum deposit: £50.00.</li> <li>• Maximum subscriptions this year: £20,000 (not including previous years).</li> <li>• You can open and manage your account: <ul style="list-style-type: none"> <li>○ Online</li> <li>○ By post</li> <li>○ In person at our office</li> </ul> </li> </ul>			
Can I withdraw money?			
<ul style="list-style-type: none"> <li>• This is a fixed-term account, so withdrawals are not permitted before maturity.</li> <li>• Any withdrawals will result in the closure of your Fixed Term Cash ISA and no interest being paid on the funds.</li> </ul>			
Can I add money to the account?			
<ul style="list-style-type: none"> <li>• You may subscribe up to the Cash ISA allowance set by HMRC for each tax year.</li> <li>• Subscriptions can be made by payroll deduction, direct debit or lump sum.</li> <li>• The maximum aggregate savings balance of your Credit Union account must not exceed £120,000 protected under the Financial Services Compensation Scheme.</li> </ul>			
Can I transfer my ISA			
<ul style="list-style-type: none"> <li>• Transfers In: Yes, via the appropriate channels to prevent loss of tax-free status.</li> <li>• Transfers Out: Yes, however early transfer will result in no interest being paid on the funds.</li> </ul>			

## Fixed Cash ISA Summary Table

What happens at maturity?
At maturity you can: <ul style="list-style-type: none"> <li>• Withdraw funds.</li> <li>• Transfer to another ISA.</li> <li>• Reinvest in a new ISA with us (if applicable).</li> </ul>
Is my money protected?
Yes. Your eligible deposits are protected by the Financial Services Compensation Scheme (FSCS) up to £120,000.
Can I cancel the account?
Yes. You have 14 days from account opening to cancel without penalty.
